Tenancy from week to week: A written or unwritten lease, characterized by payment of rent on a weekly basis, which typically requires a one week notice of termination if there is no designated expiration date.

Rental agreements are required for tenancies that are 12 months or longer in Pennsylvania. Even for leases that are less than 12 months, we encourage our landlords to enter into written rental agreements with their tenants for added legal security. In a survey of our Pennsylvania landlords, 87% had a written rental agreement.
